- Contribution to knowledge (35%)
- Alignment with the 2020 International Health Care Reform Conference Themes (30%)

Abstract Format:

Abstracts for oral or digital poster presentations must include background and aims, methodology, results and conclusion. Abstracts longer than 250 words will not be considered.

Oral Presentations


Oral presentations will be 15 minutes in total, allowing for 10 minutes for the presentation and 5 minutes for the questions. Those abstracts not selected for paper presentation may be offered a digital poster presentation.

Digital Poster Presentations

Digital poster presentations will be 'display only' on plasma screens located in the exhibition and catering areas. The plasma screen will show the list of presentations that are loaded, and attendees can peruse these during breaks. Presenters will be provided with a Power Point template to build their digital posters which can include elements such as images and videos.

Digital poster dimensions: The Power Point template is 80cm wide x 140cm high maximum (Portrait style only)

A prize will be offered for the best digital poster. Judging criteria will include:

- 1. Originality of the research idea
- 2. Relevance to primary care
- 3. Appropriateness of study design
- 4. Validity of data collection

- 7. Appropriateness of conclusion
- 8. Adequacy of discussion
- 9. Clarity and style
